Context of the research activity

**Motivation and objectives of the research
in this field**

Research will investigate ways for the revitalization, reactivation and regeneration of edge and/or marginal territories, with reference to the European context, according to a key of renewed habitability and enhancement of heritage resources.

Research, with marked traits of transversality and interdisciplinarity, intercepts, by the key words that describe its scope, multiple Missions of the National Recovery and Resilience Plan, and in particular the objectives of Missions 1 and 5.

Research objectives are to define scenarios, projects, and integrated policies capable of outlining virtuous evolutionary prospects for edge and marginal territories, in the specificity of contextual conditions and with an effective thematization of the relationship between the endogenous and exogenous resources to the territories themselves.

From the methodological point of view, research may combine different ways and approaches, depending on the specific characters of the programs proposed by the candidates, combining historical approach about policies for the development of peripheral contexts, analytical-



	<p>comparative approach to investigate contemporary experiences, including in the European international panorama, experimental approach for the development of initiatives and models that can configure evolutionary hypotheses for local development and for the policies of heritage resources enhancement in the broadest sense. Six months will be dedicated to a period abroad in the UVA Universidad de Valladolid, Departamento de Urbanismo y Representación de la Arquitectura, Instituto Universitario de Urbanística.</p> <p>The PhD programme, lasting three years, calls for the acquisition of minimum 25 credits divided as follow: 15 credits (minimum) offered by PhD courses organized by the PhD programme in Preservation of the Architectural Heritage; 10 credits offered by the PhD School (transferable and soft skills).</p> <p>Periodical milestones (every six months approximately), starting from the first year, will verify Ph.D. students' progress in individual research.</p>
Educational objectives	<p>The goal is to train a researcher figure possessing specific skills related to the enhancement of the potential of heritage resources, both tangible and intangible, of edge and marginal territories, capable of grasping and promoting their possibilities and perspectives for renewed habitability.</p>
Job opportunities	<p>The research type and the figure of researcher trained through it can find an exit into occupations that are not limited to the contexts of university and scientific research, but are open in general to study centers, research institutes, and institutional bodies and entities engaged both on the cognitive-interpretative side and on the project-operational and administrative-management side, in the elaboration of spatial, economic and social policies for edge and marginal territories.</p>
