Context of the research activity		
Motivation and objectives of the research in this field	Young innovative firms are a key engine of economic growth but face serious challenges in accessing the external finance necessary to realize their potential. These difficulties are magnified for minorities, females and entrepreneurs located in peripheral areas far from financial hubs. This project will investigate whether and how the advent of digital finance helps these firms to overcome the financial barriers. More specifically, this research project will based on two related pillars, namely access to finance and impact of financing. The first will investigate whether digitalization in entrepreneurial finance facilitate the matching between entrepreneurs and investors with special attention to assessing to what extent digitalization democratizes the access to finance, making entrepreneurial finance ecosystems more inclusive. The second pillar will examine how digitalization influences the long-term impact of external finance on the growth and exit performance of recipient young innovative firms.	
Methods and techniques that will be developed and used to carry out the research	The research project will employ state of the art quantitative methods (e.g. panel data econometric techniques) to empirically investigate the aforementioned research questions. The project will build a uniquely comprehensive data infrastructure by extending to digital financial channels the VICO 5.0 database developed at
